



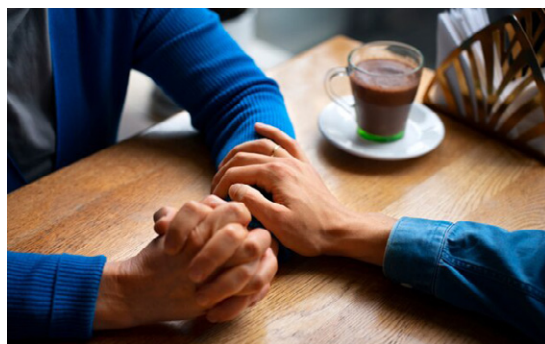

Dear Friends,

JFS Fiscal Year 2022-2023 was filled with activity at Jewish Family Service of MetroWest NJ. With more than forty programs ranging from support for adults with developmental disabilities, to helping Holocaust Survivors age with dignity in their homes, to meaningful volunteer opportunities, JFS has been there, responding to the community's needs each and every day.



Through our Florin Education Series on Domestic Violence, we heard from Katrina Brownlee, a woman who had experienced severe domestic violence, and then joined the New York Police Department to help change the system that had let her down. Over the course of the year, we assisted more than 1900 victims of domestic violence through counseling, direct legal representation, court advocates, and our Pro Bono Legal Program.

We celebrated our first annual Holocaust Survivor Day, a day created to recognize the accomplishments of survivors and the ways they enrich humanity every day. It has been a privilege to join communities across the globe in acknowledging the contributions that survivors have made to society and to honor their legacies. We look forward to celebrating Holocaust Survivor Day in the years to come.

We created two new Diversity, Equity and Inclusion committees, one for our staff and one for our Board, to ensure our agency best represents the diverse communities we serve. As a non-sectarian agency we are committed to ensuring that all in our community feel heard and safe. The staff committee is focusing on ways to be more inclusive to our diverse employees, while the board committee is focused on ensuring we have representation and perspective from all the diverse cultures and people we serve.

Our Annual Gala this year, An Evening of Broadway, recognized Melanie and Alan Levitan and Joanne and Arthur Weinbach, along with our Rachel Coalition Legal Services. We enjoyed a Broadway style cabaret performance in front of a packed house of JFS supporters. We are so grateful to have so many trustees, individuals, companies, foundations, and partners, who are committed to keeping JFS going and are excited to see what the future brings.

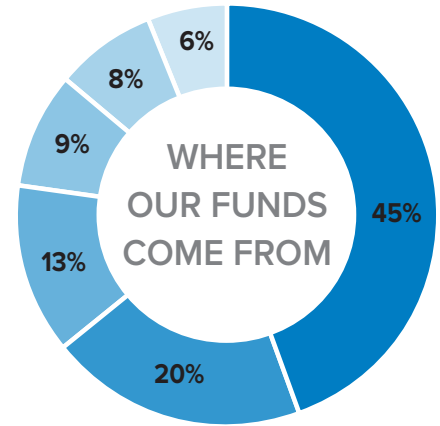

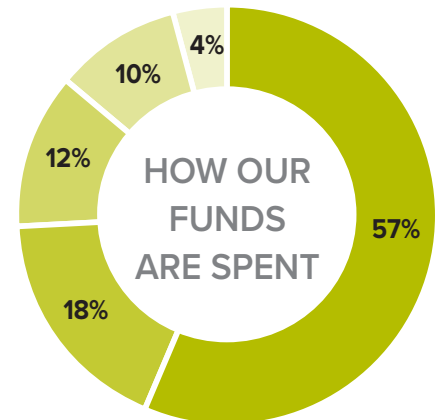
