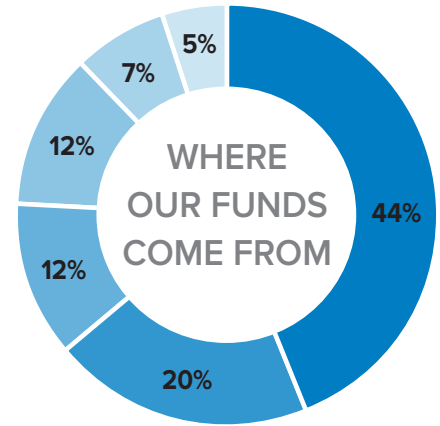

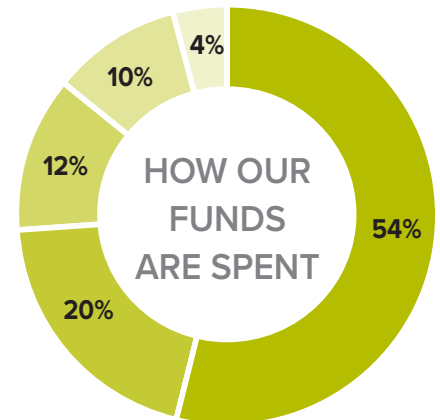

Dear Friends,

What a year this has been! We started in July with the expectation of business as usual and moved through the summer with all going well. And then, October 7th. Our worlds were rocked, and here at JFS, we immediately jumped into action, working to support the community members who were as devastated as we were.

On Monday, October 9th, the management team came together and started the day with an emergency meeting, working to anticipate what the concerns and needs of the community would be. We worried about our Holocaust survivors, as we imagined they could be experiencing trauma reactions and would need support. We talked about specific populations that might need their own groups moving forward...parents of lone soldiers, parents with children in college, Israeli families in the community, our Rishonim (exchange students from Israel who were here for a year through a Federation program). We talked about all the resources at our disposal we thought could be helpful. And then we acted, providing drop-in support groups, individual therapy, fielding phone calls, and making sure the community knew we were there to help.

The work of October 7th continues every day and will continue for as long as it needs to. So, what has this past year been? A combination of crisis response and business as usual. Our domestic violence division, Rachel Coalition, has worked with over 2,000 people through counseling and legal services. Our intake line received 2,263 calls this past year, a consistent increase of 10% each year since June of 2022. And more than 200 Holocaust survivors received services including outreach, advocacy, and case management. Over 500 clients have come to us for counseling, and we are taking on new clients every day.

Our gala this year saw three new awards presented: the Lifetime Philanthropy award which went to Carol and Bob Marcus for their years of unwavering dedication and support of JFS, the Rising Star award, which went to Board member Stephen Weinstein who has been instrumental in getting our corporate fundraising initiatives off the ground, and the Community Partner award, which went to Sunrise Shoprite for over 20 years of support provided to Rachel Coalition services. JFS is indeed lucky to have such champions, and of course the support of all of our trustees, donors, foundations, corporate sponsors, and all in the community who know us and support us.

As we move into fiscal year 2025, we have a lot to look forward to at JFS. We are pleased to be introducing several innovative programs into the community. With a grant from the Healthcare Foundation of New Jersey (HFNJ) we received funding to hire a mental health professional to support the Greater MetroWest Hillel programs, found in 6 universities in Morris and Essex County. With the increase in antisemitism on college campuses, we are pleased to partner with HFNJ to provide mental health support and resources.

Through the Jewish Federations of North America's Center on Holocaust Survivor Care and Institute on Aging and Trauma, (JFNA), JFS is proud to have received a grant to provide new programming for homebound seniors, Holocaust survivors, and caregivers of those with dementia who will be supported by volunteers in the community. The Caregiver Respite Program offers respite to caregivers in the community through qualified volunteers coming to their house to support the caregiver's loved one while the caregiver takes a break. The Shop & Drop Program pairs an older adult with a volunteer to food shop on a weekly or biweekly basis.

We will be moving into new space in Florham Park and West Orange, allowing us to expand our scope of services. We are embarking on a new strategic plan, taking a critical look at our programs and services, and ensuring that we are focusing moving forward on community needs, as we have done since 1861.

Please take a look through these pages at all we have accomplished during a difficult year. We are proud of the work we do here and could not have done it without you!

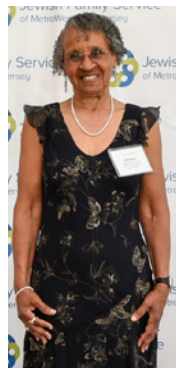
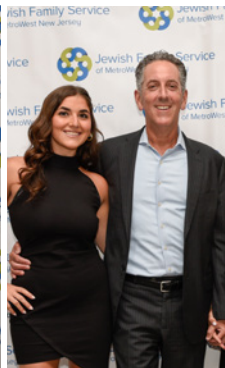
